Sacred Intent on the Seventeenth Day of the Planting Moon, Year of
2025

CALLING

the voices of ancestors who speak through time
As we bind our nations in sacred trust and common purpose
let the Four Directions witness this covenant made in good faith
let the smoke of our council fires rise to the heavens as one

Wampum Row First. This Treaty agreement flows like living water between the
MUND BAREEFAN EMBASSY CLAN/INDIGENOUS NATIVE AMERICAN ASSOCIATION
OF NATIONS and THE OFFICIAL LEAGUE OF INDIAN NATIONS OF NORTH AMERICA
binding our streams and rapids into a mighty river of cooperation, restoration,
self-determination

Wampum Row Second. the Keepers of Sacred Ways, descendants of
who walked this land the time beyond memory, do hereby proclaim our
shared vision, our mutual respect and our solemn commitment to uphold this
covenant between our people

THE SACRED FOUNDATION:

1. We affirm that self-determination and sovereignty dwells in the hearts and spirits of the People, not in distant halls of federal power
2. We declare that those who reach beyond their granted authority act against natural law
3. We acknowledge that powers retained are powers preserved by our Indigenous Nations

Wampum Row Third. Our alliance draws strength from the deep roots of our constitutional authority

1. As the eagle soars between mountain and sky, so our nation's stand between earth and heaven, bearing witness that:
2. MBC/INDIGENOUS NATIVE AMERICAN ASSOCIATION OF NATIONS stands as a Hague-level Authenticated Indigenous Government, recognized in America and across the waters that separate continents. Our wisdom is housed in the MBC/INAAN Constitution's Organic Laws and in the MBC-INAAN CONSTITUTION Bill of Rights (and is administered through our MBC/INAAN Code Annotated).
3. OFFICIAL LEAGUE OF INDIAN NATIONS OF NORTH AMERICA CA Constitution and principles; bears full validity and recognition internationally by the International Parliament for Safety and Peace and the Vienna Convention of April 19, 1961.

Wampum Row Fourth. THE CIRCLE OF COMMERCE AND COMMUNITY

Like the sacred trading paths that once connected our ancestors across valleys and mountains, we now re-establish paths of mutual prosperity:

Each Nation shall retain the unfettered right, as given by the Creator Giver of Breath:

1. To establish private commerce and trade that nourishes our peoples;
2. To create zones of economic healing and growth upon our lands;

3. To issue currency or tokens of exchange blessed by our own hands;
4. To join our skills and resources across boundaries drawn by others our nations shall flow together like tributaries joining a sacred river;
5. Sharing wisdom and resources to strengthen both our peoples;
6. Supporting one another's sovereignty in matters of trade and diplomacy;
7. Protecting the sacred responsibility of self-determination
8. Honoring the ways of our ancestors while embracing the possibilities of tomorrow;

Wampum Row Fifth. THE SOVEREIGN COVENANT

This agreement stands upon the bedrock of natural law and is upheld by the breath of the Creator. It is both a spiritual covenant and lawful bond – honored by the free will of sovereign nations, each retaining their inherent right to walk their own path.

We enter this sacred agreement with clear eyes and open hearts, knowing that:

1. Our words are witnessed by ancestors who watch from beyond the veil
2. Our promises are sealed in the Book of memory
3. Our intentions are judged by powers greater than mortal authority
4. Our covenant shall be respected while it serves the highest good of each nation

Wampum Row Sixth. THE SACRED IMPLEMENTATION, THE CEREMONY OF SEALING

As autonomous indigenous nations, sovereigns joined in mutual respect, each nation reserves the sacred right to withdraw from this covenant through formal declaration should their path diverge, with no requirement for the other's consent. Such is the nature of true sovereignty, autonomy – freely given, freely maintained, freely relinquished when the spirit guides.

A. This covenant (is) shall be made manifest through solemn rites performed by the OFFICIAL LEAGUE OF INDIAN NATIONS OF NORTH AMERICA CA and the INDIGENOUS NATIVE AMERICAN ASSOCIATION OF NATIONS under their full Autonomy, requiring no permission or sanction from outside powers.

The ceremony shall include:

1. The sacred reading of this covenant, each word given voice in the presence of appointed witnesses
2. The spoken affirmation: "I do hereby affirm this covenant, under the authority of my Nation and before the Great Spirit and those gathered here today. I bind myself and my successors to its peace and perpetuity."
3. The marking of signatures by the hands of those empowered to speak for their nations
4. The pressing of sacred seals that carry the spiritual authority of our peoples
5. The witnessing of these acts by those chosen to remember and testify

Wampum Row Seventh. THE PRESERVATION OF MEMORY

As our ancestors preserved sacred knowledge through stories and symbols, we shall preserve this covenant:

1. Each Nation shall guard an original text like a sacred fire
2. Copies shall be protected by flame-resistant shields, climate-controlled lodges, and digital encryptions
3. Our agreement may be shared with:
4. The tribal memory keepers
5. Those who defend the rights of Indigenous peoples across the great waters
6. The keepers of public records, that our covenant may stand as evidence of our autonomy

Wampum Row Eighth. THE SACRED CEREMONY

This covenant is both lawful declaration and sacred vow. Its sealing shall occur:

1. Upon ground made holy by tradition, within diplomatic sanctuary, or within a council circle
2. Before the eyes of no fewer than two witnesses from each Nation
3. With the observance of ancestral rites, traditional prayers, and sacred blessings **and;** through these acts we ensure:
 - a. Legitimacy by custom and constitution
 - b. Divine recognition under spiritual law
 - c. Eternal continuation under natural law

Wampum Row Ninth. THE MANIFESTATION OF OUR VISION

When our hands have sealed this covenant, our Nations shall:

1. Proclaim with one voice our peace and self-determined relationship
2. Begin the sacred exchange of trade and cooperation as written in these words
3. Establish, if the Creator guides us to this purpose, a Council of Covenant to nurture our ongoing communion and resolve any disputes that may arise. No outside power may sever the bonds we create through this sacred covenant. This agreement stands as, shield and shelter for our peoples.

Wampum Row Tenth. THE ROOTS OF AUTHORITY

This covenant draws nourishment from deep roots:

1. The MBC/INAAAN Constitution and ANNOTATED CODE
2. THE OFFICIAL LINNA CA Constitution
3. Article VI of the Constitution for the United States
4. The Northwest Ordinance of 1787
5. The Tenth Amendment

6. The Law of Nations

7. The Universal Law of the Creator

No bureaucratic decree, executive order, regulation, or private code may diminish the power, validity, or effect of this covenant between our sovereign nations.

Wampum Row Eleventh. THE FINAL SEALING

Let it be known before Creator, the Earth Mother, and all Peoples:

THIS COVENANT IS HEREBY EXECUTED LAWFULLY.

THIS COVENANT IS FINAL.

THIS COVENANT IS SEALED.

SO, HELP US, GREAT SPIRIT, ON THIS DAY, THE SEVENTEENTH OF THE PLANTING MOON, 2025, AS WE HEREBY ATTEST.

This Covenant, including all implementation provisions, honors the sovereignty of each nation. Either party may withdraw through a formal written declaration of their intention, in accordance with their own sovereign authority

Wampum Row Twelfth. SACRED COVENANT TREATY OF NATIONS IS ...

A JOINT VENTURE AGREEMENT FOR TRADE AND INHERITED RIGHTS

Between

Sealed with Sacred Intent on the Seventeenth Day of the Planting Moon, Year of Restoration 2025 No outside power may sever the bonds we create through this sacred covenant. This agreement stands as: shield and shelter for our peoples.

Wampum Row Thirteenth. THE FINAL SEALING

Let it be known before Creator, the Earth Mother, and all Peoples:

1. THIS COVENANT IS HEREBY EXECUTED LAWFULLY.
2. THIS COVENANT IS FINAL.
3. THIS COVENANT IS SEALED.

SO, HELP US, GREAT SPIRIT, ON THIS DAY, THE SEVENTEENTH OF THE PLANTING MOON, 2025, AS WE HEREBY ATTEST.

Wampum Row Fourteenth. This Covenant, including all implementation provisions, honors the sovereignty of each nation. Either party may withdraw through a formal written declaration of their intention, in accordance with their own sovereign authority.

This Covenant stands affirmed under:

1. The Organic Laws of the MBC/INAAAN Constitution.
2. THE OFFICIAL LINNA CA Constitution
3. The Universal Law of the Creator, Giver of Breath.
4. The sacred traditions and inherent sovereignty of our peoples.

As witnessed by the eternal spirits of water, fire, earth, and air, on this Seventeenth Day of May when the buffalo grass grows tall in the Springing of new life for new harvest in the year of our Lord Two Thousand Twenty-Five.

The four directions stand as our witnesses, as do Grandfather Sky and Grandmother Earth and as do we. "As the Sun Father journeys across the sky on this 17th day when Flower Moon shows her face eighteen times, in the Season of Renewal in the year counted as 2025 by the settlers' calendar, we gather in sacred witness. As the spirits of our ancestors watch, we speak these words into being..."

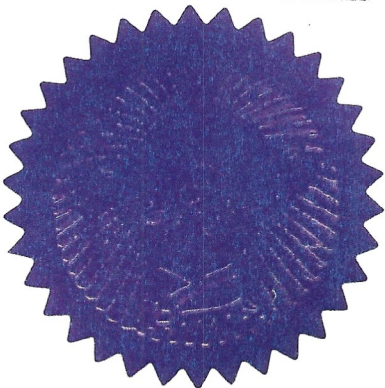
